GENERAL LIABILITY RELEASE, ASSUMPTION OF RISK, AND WAIVER OF CLAIMS

1. Participation in such events or activities involves risks of serious injury or sickness and the possible exposure to and illness from infectious and/or communicable diseases including, but not limited to, COVID-19, MRSA, influenza, and other infectious or communicable diseases. While adherence to particular rules and protocols may reduce the risk of possible injuries and exposure, the risk of serious injury, illness and death remains.
2. I knowingly and freely ASSUME ALL SUCH RISKS, both known and unknown, even if arising from the negligence or other conduct of the Released Parties (as defined below) or others, and assume full responsibility for my participation in such events or activities.
3. I agree to comply with all rules, regulations or conditions established by T&C for participation in such events or activities.

On behalf of myself and on behalf of my heirs, assigns, personal representatives, I HEREBY RELEASE AND HOLD HARMLESS T&C, its officers, officials, agents, employees, members, managers, affiliates, staff, instructors, clubs, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any events or activities in which I participate (collectively “Released Parties”), from and against any and all claims of whatever type or kind, including any claims involving illness, disability, death, or other loss or damage to person or property, whether arising from the negligence of Released Parties or otherwise, to the fullest extent permitted by law. Further, I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the State of Kentucky or any other state in which I may participate in any event or activity described herein, and that if any portion of this release is determined to be invalid, it is agreed that the remaining provisions of this release shall continue in full force and effect.
